When we say that negotiations are stalled, it is because we have spent eight weeks at the bargaining table with very few of your demands being checked off. The few that were resolved are minor. None of your priority demands received a constructive response from the Company, let alone agreement. We did not even discuss monetary issues yet: it was obvious that we needed to move the process along to a more serious step.

As you are aware, the collective agreement expired on November 30, 2016 and continues in force while we are negotiating.

At the beginning of the week we discussed, in the presence of the conciliation officers, the « Maintenance of Activities » protocol in the event of a strike or lockout. We did not reach an agreement on the protocol. The Company therefore made a request to the *Canada Industrial Relations Board* so that the *Board* can determine the technician work that must be maintained in order to prevent a serious and immediate danger to public health and safety.

Next, we met with the conciliation officers to explain our priority demands that we have tabled with the Employer. On Thursday and Friday, we met the Employer to further discuss our priority issues.

We will return to Ottawa next week to continue negotiations in the presence of the conciliation officers.

After eight weeks of meetings with the Company and two more weeks of negotiations in the presence of the Conciliator, your Committee has bargained day and night to get a deal prior to the holidays. Today the Company left the bargaining table. Your Committee has concluded that the Employer is only prepared to settle on its own terms. At the same time the Company has made it clear that they have plans to contract out more bargaining unit work.

The Company has turned a deaf ear to your priorities.

- Outsourcing and work jurisdiction
- Wage parity for employees hired after 2012
- Article 11 coverage for all employees
- The right to grieve and arbitrate the denial of sick pay
- Seniority rights
- Fair and equitable transfers and reassignments

Accordingly, at the beginning of January we will hold information meetings in each Local to ask you for a strike mandate. We believe that the Employer will only move if they are convinced that we are ready to fight for our priorities and to save our jobs.

We will return to the bargaining table along with Jerry Dias on January 13th, 14th, 15th and 16th in Montreal.
